PLAN - MAILBOX TURNOUTS

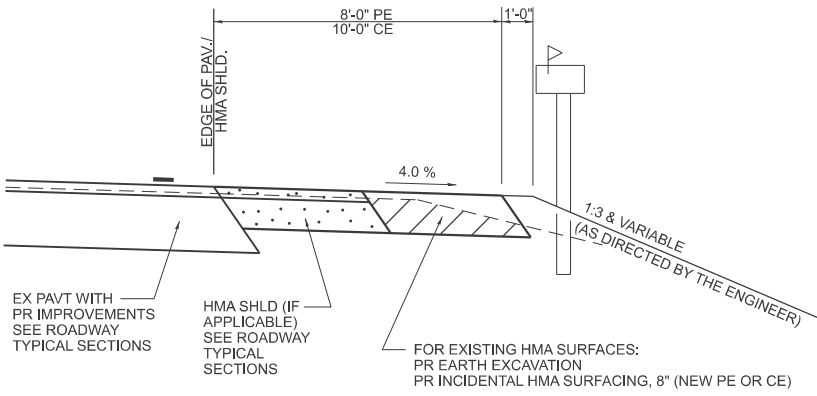
