Contractor shall give Engineer prompt, written notice if Contractor believes that any significant changes in the Work or variations from the Contract Documents is required because of action taken in response to an emergency, a Work Directive Change or Change Order will be issued to document the consequences of the changes or variations.

Compliance with this special provision shall be considered included in the cost of the contract and no additional compensation will be allowed for any costs incurred.

There may also be utilities for which the presence and location are unknown. Verification of locations of underground utilities, shown or not shown, will be the responsibility of the Contractor.

This item shall include furnishing, operating and maintaining all temporary traffic signals as shown on the staging details for the construction of the project.

Temporary Bridge Traffic Signals (Special) will be measured for payment as each, where each is defined as the entire traffic signal system regardless of the number of signal heads.

This work will not be measured or paid for separately and shall be included in the LUMP SUM contract unit price for TRAFFIC CONTROL AND PROTECTION, (SPECIAL) and no additional compensation will be allowed.
