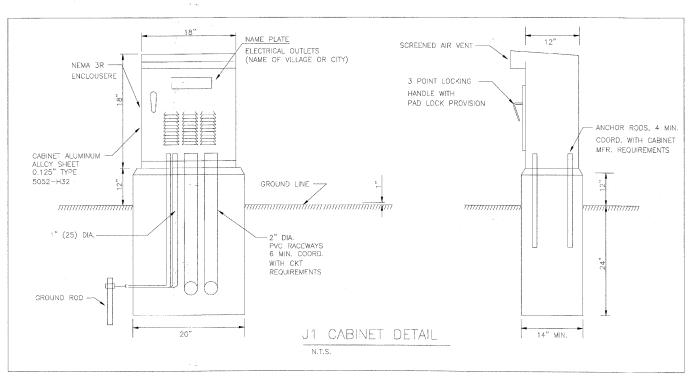

- 5. ALL WIRING SHALL BE NEATLY DRESSED AND SUPPORTED.
- 6. FOUNDATION SIZE SHALL BE COORDINATED WITH CABINET SIZE AND MFR.
- 7. DOOR SHALL BE CONSTRUCTED FROM SAME TYPE OF MATERIAL AND THICKNESS AS CABINET. 8. DOOR SHALL BE EQUIPPED WITH THREE POINT
- LATCHING MECHANISM WITH NYLON ROLLERS AT TOP THE BOTTOM. 9. DOOR HINGE SHALL BE A HEAVY GAUGE
- CONTINUOUS HINGE WITH A 1/4" (6.35 mm)
 DIA. STAINLESS STEEL HINGE PIN.
