## **ADDITIONAL INSURED**

In addition to the insurance requirements of Article 107.27 of the Standard Specifications, the Contractor shall purchase insurance certificates in the name of Ela Township. The insurance certificates shall be for public liability and property damage in which Ela Township, its commissioners, officers, agents and employees are named insured as well as fire and extended coverage and all risk property insurance ('CLAIMS MADE" policies are unacceptable) in which Ela Township is named loss payee from a company to be approved by Ela Township. Each afore-referenced policy shall have limits of not less than the following:

COMPREHENSIVE GENERAL LIABILITY  
Combined Single Limit Bodily Injury Liability  
Property Damage Liability (Including Liability for  
Environmental Contamination of Adjacent Properties)  
In the amount of not less than \$2,000,000.00 per Occurrence  
and  
ALL RISK PROPERTY INSURANCE  
(Including Coverage for Environmental  
Contamination of Easement Premises)  
in the amount of not less than \$2,000,000.00  
per Occurrence

In addition to the insurance certificate, prior to entering parcel 1EB0012 and TE, the Contractor shall execute and lodge with Ela Township a performance bond in the sum of \$5,000.00 and it shall be in a form satisfactory to the Attorney for Ela Township.

All costs for additional insurance and performance bond as specified above will not be paid for separately, but included in the cost of the contract.
